Introductory Reporters' Note

The proposed revisions to the text of the act set forth in this document have been prepared as part of a project that has two purposes: (i) to harmonize the language of all of the unincorporated entity laws, and (ii) to revise the language of each of those acts in a manner that permits their integration into a single code of entity laws.

The Comments to the act have been omitted from this document to reduce its length. Following the approval of the changes in this document by the Conference, the Comments will be restored with appropriate changes.

The harmonization process has involved the revision of the following acts, some of which are referred to in the Reporters' Notes by the abbreviations listed below:

8 (a) This [act] may be cited as the Uniform Business Organizations Act Code.

2 (c) Registration of a foreign entity to do business in this state does not authorize ~~FF~~ THE
3 FOREIGN ENTITY to engage in any activity or exercise any power that a domestic entity of the
4 same type may not engage in or exercise in this state.

5 **SECTION 1-502. REGISTRATION TO DO BUSINESS IN THIS STATE.**

6 (a) A foreign filing entity or foreign limited liability partnership may not do business in
7 this state until it registers with the [Secretary of State] under this [article].

8 (b) A foreign filing entity or foreign limited liability partnership doing business in this
9 state may not maintain an action OR PROCEEDING in this state unless it is registered to do business
10 in this state.

11 (c) The failure of a foreign filing entity or foreign limited liability partnership to register
12 to do business in this state does not impair the validity of a contract or act of the foreign filing

15 (d) ~~THE~~ A LIMITATION ON THE liability of an interest holder or governor of a foreign filing
16 entity or of a partner of a foreign limited liability partnership ~~IS GOVERNED BY THE LAWS OF ITS~~
17 ~~JURISDICTION OF FORMATION. ANY LIMITATION ON THAT LIABILITY~~ is not waived solely because
18 the foreign filing entity or foreign limited liability partnership does business in this state without
19 registering.

12 (4) maintaining offices or agencies for the transfer, exchange, and registration of

15 (5) selling through independent contractors;

16 (6) soliciting or obtaining orders by any means if the orders require acceptance

18 (7) creating or acquiring indebtedness, mortgages, or security interests in

20 (8) securing or collecting debts or enforcing mortgages or ~~OTHER~~ security interests
21 in property securing the debts, and holding, protecting, or maintaining property so acquired;

22 (9) conducting an isolated transaction that is not in the course of similar
23 transactions; ~~AND~~

1 (10) owning, without more, property; and

2 (11) doing business in interstate commerce.

11 not later than [six months] after it is due;

12 (2) deliver [an annual] [a biennial] report to the [Secretary of State] not later than [six

14 (3) have a registered agent in this state for [60] CONSECUTIVE days.

15 **SECTION 1-602. PROCEDURE AND EFFECT.**

16 (a) If the [Secretary of State] determines that one or more grounds exist under Section 1-
17 601 for ADMINISTRATIVELY dissolving a domestic filing entity, the [Secretary of State] shall

9 (d) The administrative dissolution of a domestic filing entity does not terminate the
10 authority of its registered agent.

11 **SECTION 1-603. REINSTATEMENT.**

12 (a) A domestic filing entity that is dissolved administratively under Section 1-602 may
13 apply to the [Secretary of State] for reinstatement [not later than [two] years after the effective
14 date of dissolution]. The application must BE SIGNED BY THE ENTITY AND state:

15 (1) the name of the entity at the time of its administrative dissolution and, if
16 needed, a different name that satisfies Section 1-301;

23 due to the [Secretary of State] at the time of its administrative dissolution and all fees, taxes, and

1 penalties that would have been due to the [Secretary of State] while the entity was dissolved
2 administratively.

3 (c) If the [Secretary of State] determines that ~~the~~ an application under subsection (a)
4 contains the information required by subsection (a), is satisfied that the information is correct,
5 and determines that all payments required to be made to the [Secretary of State] by subsection
6 (b) have been made, the [Secretary of State] shall:

16 AFFAIRS as if the administrative dissolution had never occurred, except for the rights of a person
17 arising out of an act or omission in reliance on the dissolution before the person knew or had
18 reason to know of the reinstatement.

3 (b) An entity may seek judicial review of denial of reinstatement in the [appropriate

6 MISCELLANEOUS PROVISIONS

7 **SECTION 1-701. RESERVATION OF POWER TO AMEND OR REPEAL.** The
8 [legislature of this state] has power to amend or repeal all or part of this [act] at any time, and all
9 domestic and foreign entities subject to this [act] are governed by the amendment or repeal.

10 **SECTION 1-702. SUPPLEMENTAL PRINCIPLES OF LAW.** Unless displaced by
11 particular provisions of this [act], the principles of law and equity supplement this [act].

12 **SECTION 1-703. UNIFORMITY OR CONSISTENCY OF APPLICATION AND**
13 **CONSTRUCTION.** In applying and construing the [articles] of this [act] based on uniform or
14 model acts, consideration must be given to the need to promote uniformity or consistency of the
15 law with respect to its subject matter among states that enact it.

16 **SECTION 1-704. SEVERABILITY CLAUSE.** *If any provision of this [act] or its*
17 *application to any person or circumstance is held invalid, the invalidity does not affect other*
18 *provisions or applications of this [act] which can be given effect without the invalid provision or*
19 *application, and to this end the provisions of this [act] are severable.*

8 incurred under the statute before its repeal;

9 (3) any violation of the statute or any penalty, forfeiture, or punishment incurred because
10 of the violation before its repeal; or

11 (4) any proceeding, reorganization, or dissolution commenced under the statute before its
12 repeal, and the proceeding, reorganization, or dissolution may be completed in accordance with
13 the statute as if it had not been repealed.
