Effective September 16, 2010, certificates of existence issued by the New York Department of State for corporations and other business entities will be produced with a gray laser facsimile of the Department of State seal. The blue Department of State seal will no longer be used on certificates of existence.

There will be no changes to certificates of existence produced off-site by authorized service companies. Certificates of existence produced off-site will continue to include a black facsimile of the Department of State seal.
