## **Additional Comments:**

Dear All,

This goes way back, at least 15 years, so my aging memory is a little fuzzy. But I recall that we looked into UCC filing with regard to the sovereign native nations. My best, though faint, recollection of that is as follows. The native nations that have sovereignty under their treaties have the option of either developing their own legal and institutional ST frameworks for their separate nations or relying on the concurrent jurisdiction of the state. As I recall, the Navajo Nation and perhaps the Flathead Nation decided to go with the separate option and adopted Article 9. I don't recall that any of the others did, so they rely on concurrent jurisdiction as the default option. Therefore, those filings would be done under the state law, the same as any other filing. Keep in mind that this is all based on a fuzzy, ancient memory, so it may not be exactly correct. And things may have changed in the past 15+ years, too.

Minnesota Secretary of State Mark Ritchie and the Leech Lake Band of Ojibwe will sign Joint Sovereign Filing Systems Joint Powers Agreement on Friday, October 21 in State Capitol Rotunda St. Paul, Minn.

October 18, 2011—Minnesota Secretary of State Mark Ritchie will sign the Joint Sovereign Filing Systems Joint Powers Agreement with the Leech Lake Band of Ojibwe on Friday, October 21 in the State Capitol Rotunda at 2 p.m. This Uniform Commercial Code (UCC) joint powers agreement will help reduce lending barriers American Indian tribes, tribal entities, tribal member-owned businesses, and American Indian consumers encounter when seeking financing by creating a legal infrastructure for securing transactions with off-reservation commercial lenders and businesses.

"This joint powers agreement will allow members of the Leech Lake Community to more easily access capital and provide greater economic opportunities beneficial to our whole state," said Secretary Ritchie.

Once signed, the Leech Lake Band of Ojibwe will have access to Minnesota's Uniform Commercial Code (UCC) filing system which will serve as the registry for tribal liens. By using the state's UCC system lenders would be assured of stability and security within tribal loan practices and laws.

"Tribal leaders from Leech Lake, the National Conference of Commissioners on Uniform State Laws, the Federal Reserve Bank of Minneapolis and the Minnesota Indian Business Alliance have worked tirelessly to craft this historic agreement that will encourage new business development and employment growth. This is a very positive step forward for all Minnesotans," concluded Secretary Ritchie.
