Driving directions from airport to Delta Hotel Winnipeg:

1. Head **south** on **Wellington Ave** toward **Administration St.**
2. Slight **right** at **Flight Rd.**
3. Turn **left** at **Sargent Ave,**
4. Take the 3rd **right** onto **King Edward St S/Rte 90 S.** Continue to follow Rte 90 S.
5. Take the ramp to **Portage Avenue /MB-1/Trans Canada Highway /MB-85.**
6. Turn **left** at **Portage Ave/Trans-Canada Hwy/MB-1 E/Rte 85 E** (signs for **MB-85 E**).
7. Turn **right** at **Broadway/Trans-Canada Hwy/MB-1 E** (signs for **Trans Canada Highway E**).

8. Turn left at **Hargrave St.**
9. Turn left at **St. Mary Avenue.**
